



Susan G. Komen for the Cure College Scholarship Program

Program Overview

Eligibility

Applicants must meet **all** of the following criteria to be eligible for this scholarship:

- Must have lost a parent/guardian to breast cancer or be a breast cancer survivor diagnosed at 25 years or younger
- Must be a high school senior, college freshman, sophomore or junior
- Must plan to attend a state-supported college or university in the state where they permanently reside (students in Washington DC can attend state-supported schools in Maryland and Virginia)
- Must have a high school and/or college GPA of 2.8 on a 4.0 scale
- Must be no older than 25 years old by May 2010
- Must be a U.S. citizen, or documented permanent resident of the U.S. (or US Territory)
- Never at any time have been subject to any disciplinary action by any institution or entity, including, but not limited to, any educational or law enforcement agency

Deadline

February 15, 2010

Award Distribution

- The scholarship is a renewable award of \$5000 per semester.
- It is renewable for up to 4 years to complete undergraduate studies.
- The scholarships will be applied to tuition, fees, books, supplies and equipment required for course load.
- Institutions must be accredited, nonprofit two or four-year colleges/universities in the United States.
- A student may make a one-time transfer from one institution to another and retain the award as long as it is in the permanent state of residence.

Selection Criteria

An independent selection committee will evaluate the applications and select the winners.

- The committee will consider:
 - Applicants' financial need
 - Community involvement
 - Essay content
 - Letters of reference
 - Academic achievements or records, including high school and/or college GPA, academic awards and honors.

Decisions of the selection committees are final and are not subject to appeal. No application feedback will be given.

Recipient Requirements

- Serve as a Komen Collegiate Ambassador by raising breast cancer awareness on your college campus
- Complete a minimum of 20 community service hrs each semester at a Komen Affiliate or local breast cancer organizations to demonstrate commitment as a Komen Collegiate Ambassador. Hours may also be accumulated for breast cancer awareness projects or fundraisers implemented on campus or in the community.
- You must enroll as a full time undergraduate in the fall of the year in which the scholarships are awarded.
- You must continue in school the entire academic year without interruption unless approved by scholarship sponsor.
- You must deliver your scholarship check(s) to the proper office at your institution.
- We strongly encourage you to attend the Komen College Scholarship Awards Dinner, Komen orientation session, and the Global Race for the Cure in Washington D.C., June 4 through 6, 2010.

Frequently Asked Questions

I have several potential school choices. Which one should I list on the application?

You should list your first choice on the application. If you are chosen to receive an award, you will be able to make modifications to your decision and it will be your responsibility to make certain ISTS is aware of your final school choice so that your check can be issued accordingly. Please remember you must attend a school in the state where you permanently reside to be eligible to receive this award.

How and when will I receive notification?

- Notifications are sent approximately two months past the deadline.
- Winner notifications will be sent via USPS.
- Non-winner notifications will be sent by email.
- Add info@applyists.com to your email address book or "safe senders list" so these important emails are not sent to your junk mail folder.
- **Do not 'opt out' of any email sent from info@applyists.com you may not receive vital information regarding your scholarship applications.**

How and when are checks issued?

- Checks will be mailed to each recipient's mailing address as entered on the application.
- Checks will be made payable to the institution only.
- Checks will be issued in August and December.
- It is the recipient's responsibility to notify ISTS should the check not arrive within 30 days of the issue date.

Note: Your email address will only be used to communicate with you about your scholarship applications or other opportunities administered by ISTS for which you may be eligible to apply. We will not provide your email address to any third-parties.

Where and when should I send my supporting documents?

- Upload your required documents online. If you are unable to upload them, mail or fax your supporting documents following the instructions printed from your online application. If you do not follow the instructions exactly your application may not be considered.
- Your submission must be complete by February 15, 2010.

Are scholarships taxable?

Tax laws vary by country. In the United States, scholarship funds used exclusively for the payment of tuition or textbooks are normally not taxable. The scholarship recipient is responsible for taxes, if any, that may be assessed against your scholarship award. We recommend consulting your tax advisor for more guidance.

Program Administration

To assure complete impartiality in selection of winners and to maintain a high level of professionalism, the program is administered by International Scholarship and Tuition Services, Inc., a firm that specializes in managing sponsored scholarship programs.
